PART VI.

SECTION I.—Subject to the provisions of the Trade Boards Acts, the proposed variation of Minimum Rates of Wages set out in this Schedule shall apply to all Male and Female workers (other than those specified in Section II of this Part) in respect of all time during which they are employed in Scotland in any branch of the trade specified in the Trade Boards (Milk Distributive) Order, 1920, and as set out in Section II of Part VI of the Trade Boards Notice M.D.S. (4).

SECTION II.-The proposed variation of Minimum Rates of Wages set out in this Schedule does not apply to :---

Workers employed in collection or delivery work by horse, motor, steam or oil driven vehicle, in garaging, in horse or motor keeping, in cleaning vehicles, or in stable work, in respect of the time during which they are so employed.

The Trade Board will consider any OBJECTIONS to the above proposals to vary Minimum Rates of Wages which may be lodged with them within two months from 22nd September, 1922. Such objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Milk Distributive Trade. Board (Scotland), 1, Whitehall Gardens, London, S.W. 1.

It is desirable that the objections should state precisely, and so far as possible with reasons what is objected to.
