Garnett Bridge Road from the Kendal-Shap road on Skelsmergh Fell to Stockdale Bridge.

Under Loughrigg Road from the Ambleside-Keswick road at Pelter Bridge to the Ambleside-Skelwith road at Rothay Bridge.

Drybeck Road, Killington, from the cross roads 200 yards north of Eggholme Farm via Hallbeck to the White Hall-Beck Side road.

The Askham-Fernilea road from the Bampton Grange-Askham road at Askham to the Pooley Bridge-Eamont Bridge road at "Fernilea," near "Celleron."

THE ROADS ACT, 1920.

COUNTY OF MONTGOMERY.

Whereas by sub-section (4) of Section 7 of the Roads Act, 1920, it is enacted that the Minister of Transport may, by order on the application of any County Council (as defined in Section 17 of the Act) after holding a public

inquiry, prohibit or restrict, subject to such exceptions or conditions as to occasional user or otherwise as may be specified in the order, the driving of mechanically-propelled vehicles of any specified class on any specified highway within the area of the council in any case in which it appears to him, as the result of the inquiry, to be proved that a vehicle of that class cannot be used on that highway without endangering the safety of the vehicle or the persons therein or of other traffic using the highway, or that the highway is unsuitable for use by a vehicle of that class;

And whereas the County Council of Montgomery have made application to the Minister of Transport for an Order to be made in pursuance of the said sub-section prohibiting or restricting, subject to such exceptions or conditions as to occasional user or otherwise as may be specified in the Order, the driving of any mechanically-propelled vehicle engaged in the haulage of timber on the highways or portions of highways specified in the Schedule hereto, during the period 1st October to 31st

March in each year:
