### LAND DRAINAGE ACT, 1918.

#### *River Cale and Cary Moor Drainage District (Dorset and Somerset.)*

Notice is hereby given, that the Ministry of Agriculture and Fisheries has settled and made an Order under the Land Drainage Act, 1918, constituting a new drainage district, comprising certain lands in the valley of the River Cale between Wincanton and the outfall of the River Cale into the River Stour, in the counties of Dorset and Somerset, and certain other lands, known as Cary Moor, in the parishes of Lovington, North Barrow, Alford and Castle, in the county of Somerset, and that the Order will become final and have effect as an Act of Parliament unless within thirty days from the date of this notice a memorial that the Order shall not become law without confirmation by Parliament is presented to the Ministry by some person or body affected by the Order, and having such interest as is prescribed by Article 4 of the Land Drainage Regulations, 1918 (Statutory Rules and Orders, 1918, No. 1605), as being sufficient for the purpose.
