1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

1. No animal shall be moved out of the Show Ground of the Dairy Show, Royal Agricultural Hall, Islington, in the County of London, except with a licence granted by an Inspector or other officer of the Ministry of Agriculture and Fisheries, subject to such conditions as the Minister considers necessary or expedient for the purpose of preventing the spread of disease.

2. The term "animal" in this Order includes cattle, sheep, goats, and swine.

3. If an animal is moved or otherwise dealt with in contravention of this Order or of the conditions of a licence granted thereunder, the owner of the animal and the person for the time being in charge thereof shall be deemed guilty of an offence against the Diseases of Animals Acts, 1894 to 1914.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

MIDDLESEX AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1922 (No. 2).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

Provision for Movement of Animals into Prohibited Area for Immediate Slaughter.

1. Notwithstanding the Middlesex and District (Foot-and-Mouth Disease) Order of 1922, animals may be moved from premises outside the Prohibited Area to which that Order applies to a railway station in any borough or urban district in that area, and thence to a slaughterhouse in the same borough or urban district, subject to the following conditions:—

(i) A licence authorising the movement must be obtained from the Local Authority of the destination before the movement commences. This licence must accompany the animals throughout the whole movement.

(ii) The animals must be put on rail at a station outside the Prohibited Area, and be moved by railway without being untrucked within the Prohibited Area until arrival at the station of destination.

(iii) No animal shall be moved with such a licence on any road or other highway within two miles of any Foot-and-Mouth Disease Infected Place.

#### Short Title.

2. This Order may be cited as the MIDDLE-SEX AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1922 (No. 2).
