MANCHESTER DISTRICT (FOOT-AND-  
MOUTH DISEASE) ORDER OF 1922  
(No. 5).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

*Further Contraction of Scheduled District.*

1. The Manchester District (Foot-and-Mouth Disease) Order of 1922 shall apply only to the ramp and loading stage on the premises of the London and North-Western Railway Company, situate between Water Street and the River Irwell, in the city of Manchester, and such premises shall continue to be a Prohibited Area for the purposes of the Foot-and-Mouth Disease (Control of Movement) Order of 1920.

*Commencement.*

2. This Order shall come into operation on the twenty-fifth day of October, nineteen hundred and twenty-two.

*Short Title, etc.*

3. This Order may be cited as the MANCHESTER DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1922 (No. 5), and shall be read with the Manchester District (Foot-and-Mouth Disease) Order of 1922.
