W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Herlate Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 2nd day of October, 1922, in the words and figures following, that is to say:—

following, that is to say:— "We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called ' the said Benefice ') of Redhill, in the County of Southampton and in the Diocese of Winchester:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Redhill is at present exercised alternately by the Rector or Incumbent for the time being of the Rectory of the Parish of Havant, in the said County of Southampton and in the said Diocese of Winchester, and by the Rector or Incumbent for the time being of the Rectory of the Parish of Warblington, in the said County and Diocese:

"And whereas the Reverend Harold Nickinson Rodgers, Rector or Incumbent of the said Parish of Havant, and the Reverend William Burrell Norris, Rector or Incumbent of the said Parish of Warblington, are desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Redhill now vested in them as aforesaid, as such Rectors or Incumbents, should be transferred to and be vested in the Bishop for the time being of the said Diocese of Winchester:

of Winchester: "And whereas the Right Reverend Edward Stuart, now Bishop of the said Diocese of Winchester, is willing to accept such transfer and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he, the said Edward Stuart, Bishop of Winchester, has executed this Scheme as hereinafter mentioned:

"And whereas it appears to us that the transfer of the Patronage of the said Benefice of Redhill which is hereinbefore mentioned and hereinafter recommended and proposed will, in our opinion, tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of

Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the New Parish of Redhill:

"Now, therefore, with the consent of the said Harold Nickinson Rodgers, Rector or Incumbent of the said Parish of Havant, acting as such Rector or Incumbent, and with the consent of the said William Burrell Norris, Rector or Incumbent of the said Parish of Warblington, acting as such Rector or Incumbent (in testimony whereof they have severally signed and sealed this Scheme), and with the consent of the said Edward Stuart, Bishop of Winchester (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners, humbly recommend and Commissioners, propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Redhill shall be transferred from the said Harold Nickinson Rodgers and the said William Burrell Norris and from their successors, Rectors or Incumbents of the said Rectory of the Parish of Havant and of the said Rectory of the Parish of Warblington, to the said Edward Stuart, Bishop of Winchester, and to his successors in the same Bishopric; and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Edward Stuart, Bishop of Winchester, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Winchester.
