To confer upon the Undertakers additional financial powers or any other powers usually conferred upon water undertakers, and to apply to them any provisions of the Waterworks Clauses Acts, 1847 and 1863, and the Gas and Water Works Facilities Acts, 1870 and 1873, and to amend any provisions of the Bradford Water Orders, 1904 and 1909.

FRIMLEY AND FARNBOROUGH DISTRICT WATER.

(Extension of Limits of Supply; Application of Funds; Amendment of Acts.)

NOTICE is hereby given, that the Frimley and Farnborough District Water Company (hereinafter called "the Company") intend to apply to the Minister of Health, on or before the 23rd day of December next, under the Gas and Waterworks Facilities Act, 1870, for a Provisional Order to be confirmed by Parliament in the ensuing Session for the following purposes or some of them (that is to say):—

1. To extend the limits of supply of the Company so as to include therein the parish of Finchampstead, in the rural district of Wokingham and county of Berks, and so much of the parish and urban district of Alton, in the county of Southampton, as is comprised within the enclosures shown on the 25-inch Ordnance Map of the said parish and urban

district (Edition 1910), and numbered 1, 3, 4, 5, 6, 11, 12, 15, 16, 18, 19, 20, 21, 23, and so much of any public road as is immediately adjacent thereto, being the portion of the said parish and urban district lying to the north of the southern boundary of Overbury Court and Ropers Copse, and to apply to such extended limits all or some of the provisions of the Frimley and Farnborough District Water Acts and Orders, 1893 to 1915, as modified by the Frimley and Farnborough District Water (Temporary Increase of Charges) Order, 1921, and to enable the Company to exercise within their limits of supply, as so proposed to be extended, all or some of their powers under the said Acts and Orders and under the intended Order, including the breaking up and interference with roads, streets, bridges and other works, the laying down, construction and maintenance therein or thereunder of all such mains, pipes, works and conveniences as may be necessary or convenient for the purposes of the undertaking of the Company, and the levying and recovery of rates, rents and charges in respect of the supply of water afforded by them.

2. To empower the Company to apply to the purposes of the intended Order any moneys which they are now authorized to raise under any Act or Order, or which may belong to them or be under their control, and to amend, extend, alter or repeal, so far as may be necessary for the purposes of the intended Order, the said Acts and Orders and any other Act or Order relating to the Company.

And notice is hereby further given, that on or before the 30th day of November instant a copy of this Notice, as published in the London Gazette, will be deposited for public inspection with the Clerk of the Peace for the County of Berks at his office at Reading, with the Clerk of the Peace for the County of Southampton, at his office at Winchester, and with the Clerk of the Peace for the County of Surrey, at his office at Kingston-upon-Thames, and at the office of the Ministry of Health, Whitehall, London.
