DARLINGTON.

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Darlington (hereinafter called "the Corporation"), being the Urban Sanitary Authority for the said Borough, have made application to the Minister of Health for the issue of a Provisional Order, under Sections 297 and 303 of the Public Health Act, 1875, to partially repeal, alter or amend the Darlington Extension and Improvement Act, 1872, as amended by the Darlington Order, 1902, which was confirmed by the Local Government Board's Provisional Orders Confirmation (No. 9) Act, 1902, and the Darlington Order, 1912, which was confirmed by the Local Government Board's Provisional Orders Confirmation (No. 3) Act, 1912, so as—

(1) To provide that the Corporation may, with the sanction of the Minister of Health, borrow upon the security of the revenue arising from the Water Undertaking and of the District Fund and General District Rate of the Borough, such sums, not exceeding in the whole the sum of £65,000, as may be necessary for the purposes of the Water Undertaking, in addition to the moneys already authorised to be borrowed for those purposes by virtue of Section 113 of the said Act and the said Provisional Orders; and

(2) For the purposes of the Application, or for purposes connected with, incidental to, or consequent on those purposes, to make any such alteration or amendment of the said Local Act, or of any other Local Act, or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said Borough, as may be necessary or desirable:

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application;

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 5TH DECEMBER 1922.)

MIDDLESEX, SURREY AND DISTRICT (FOOT - AND - MOUTH DISEASE) ORDER OF 1922 (No. 4).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

Application of Order and Meaning of Terms.

1. This Order applies to the Controlled Area described in the Schedule. If any farm (excluding any detached part) is partly within and partly outside the Controlled Area, the whole shall be deemed to be within the Controlled Area;

"Animals" means cattle, sheep, goats and pigs,

"Slaughterhouse" means premises used habitually and solely for the purpose of slaughtering animals, but does not include a slaughterhouse which forms part of a farm.

Restrictions in Force in the Controlled Area.

2.—(a) No animal shall be moved out of the Controlled Area;

(b) No animals shall be moved without a licence under Article 3—

(i) into the Controlled Area; or

(ii) along or across any road or other highway or by water within the Controlled Area;

(c) No animal shall be permitted by the owner or person in charge thereof to stray upon any road or other highway in the Controlled Area;

(d) No market, sale or exhibition of animals shall be held in the Controlled Area, except a market or sale for fat animals intended for immediate slaughter. A licence must be obtained from the Local Authority to hold any such market or sale, and a Veterinary Inspector of the Local Authority shall attend and examine the animals exposed thereat;

(e) No slaughterhouse manure or refuse shall be moved out of the Controlled Area or be brought into contact with animals in such Area.

Movement of Animals by Licence into or within the Controlled Area.

3. Licences may be granted by an Inspector of a Local Authority for the following movements of animals only:—
