## PRESENT.

The KING's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 23rd day of November, 1922, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the consecrated Church of Saint Michael and All Angels, Camberwell, situate in the New Parish (sometime District) of Saint John the Divine, Kennington, in the County of Surrey and in the Diocese of Southwark:

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Michael and All Angels, Camberwell, situate as aforesaid:

"Now, therefore, with the consent of the Right Reverend Cyril Forster, Bishop of Southwark (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said New Parish of Saint John the Divine, Kennington, which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Michael and All Angels, Camberwell, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Michael and All Angels, Camberwell':

"And with the like consent of the said Cyril Forster, Bishop of Southwark (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said Church of Saint Michael and All Angels, Camberwell, situate as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings and burials should be paid and belong to the minister of the same church for the time being.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to

make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall seem meet.

"THE SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Michael and All Angels, Camberwell, being:—

"All that part of the New Parish (sometime District) of Saint John the Divine, Kennington, in the County of Surrey and in the Diocese of Southwark, which is bounded upon the north west by the New Parish of All Souls, Grosvenor Park, upon the north partly by the said New Parish of All Souls, Grosvenor Park, and partly by the District Parish of Saint George, Camberwell, upon the east partly by the said District Parish of Saint George, Camberwell, and partly by the District Parish of Emanuel, Camberwell, all in the said County and Diocese, upon the south by the said District Parish of Emanuel, Camberwell, and upon the remaining side, that is to say, upon the south west by an imaginary line commencing upon the boundary which divides the said District Parish of Emanuel, Camberwell, from the said New Parish of Saint John the Divine, Kennington, at a point on the southern side of Wyndham Road opposite to the middle of Farmer's Road, and extending thence north westward to and along the middle of Farmer's Road for a distance of 81 chains or thereabouts to the boundary which divides the said New Parish of Saint John the Divine, Kennington, from the said New Parish of All Souls, Grosvenor Park."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Southwark.
