in the College, or in the University, or (under the direction of the College or the University) elsewhere, which work shall be specified in the resolution by which he is elected. Provided that if the emoluments, exclusive of fees, of a Professor so elected exceed £700 a year, he shall not receive as the emoluments of his Fellowship a greater sum than will amount, together with the emoluments of his Pro-fessorship, to £900 a year." And in the fifth paragraph of the same clause of the said Statute :—. "The annual value of such Fellowship shall be not less than £200 or more than £300 per annum, clear of income tax and in-" Except as hereinafter provided, the emolument of a Fellowship shall be £200 per annum, clear of income tax and inclusive of all allowances, save as hereinafter mentioned. Every Official Fellow who is a Tutor or Lecturer may in respect of his services as such, receive out of the Corporate Revenues a further payment not exceeding £100 per annum in addition to the said sum of £200, and to such payment (if any) as may be assigned to him out of the

Tuition Fund hereinafter mentioned." is revenues of the College under the provisions and to the purposes of these Statutes shall be subject to any Statute or Statutes made for the University under the powers of the Universities of Oxford and Cambridge Act, 1877, for enabling or requiring the Colleges to make contributions out of their revenues to Uni-versity purposes, and to the payment of the charges imposed thereby."

And whereas it appears to us, the President and Fellows of the said College, that it is desirable that the said Statutes shall be altered and amended in manner hereinafter appearing:

Now we, the President and Fellows of the said College, in exercise of the powers vested in us under and by virtue of the 54th section of the Universities of Oxford and Cambridge Act, 1877, do, by this present Instrument, under our seal, alter and amend the Statutes of the said College as hereinbefore set out in manner following, that is to say:-

In Statute III., clause 13, paragraph 1, by omitting at 'the end of the paragraph the words " Provided that if the emoluments, exclusive of fees, of a Professor so elected exceed £700 a year, he shall not receive as the emoluments of his Fellowship a greater sum than will amount, together with the emoluments of his Professorship, to £900 a year," and by substituting for them the words "Provided that the emoluments, exclusive of fees, of a Professor so elected shall not, together with the emoluments of his Fellowship, exceed £1,000 a year."

In the fifth paragraph of the same clause of the said Statute by omitting the words " not less than £200 or more than £300," and by substituting for them the words " not less than £200 or more than £400."

In clause 15 of the same Statute by omitting the words "Revenues a further payment not exceeding £100 per annum," and by substi-tuting for them the words "Revenues, whenever and so long as these may permit, a further

payment not exceeding £200 per annum." In Statute XVII., clause 1, by adding at the end of the clause the words "Provided

that any charges (including any increase of existing charges) imposed or authorized to be imposed on the revenues of the College, whether for College or for University purposes, by any amending Statute made by the College on or after December 1, 1919, and subsequently approved by His Majesty in Council, shall, in the event of any deficiency of the revenues of the College in any year be postponed to any charges for University purposes imposed or authorized by any Statute in force on November 30, 1919, and not subse-quently repealed, or made by the College on or before November 30, 1919, and subsequently approved by His Majesty in Council."
