1912 (2 & 3 Geo. V., c. 20), the court may, if it thinks fit, cause him to be brought before it and require him to give security to the satisfaction of the court to keep the peace, or for his future good behaviour, as the case may require.

3. (1) This Order shall take effect as soon as it is first exhibited in the public office of the Supreme Court for Egypt.

(2) For that purpose the Judge of the Supreme Court shall, on the receipt by him of a certified printed copy of the Order, cause the same to be affixed and exhibited conspicuously in that office. He shall also keep the same so affixed and exhibited during one month from the first exhibition. (3) A certified copy of this Order shall also be affixed and exhibited in the public offices of the Consular Courts at Cairo and Port Said at the same time as it is first exhibited at Alexandria or as soon thereafter as circumstances admit.

(4) Proof shall not in any proceeding or matter be required that the provisions of this article have been complied with, nor shall any act or proceeding be invalidated by any failure to comply with any such provisions.
