petual right of Patronage of and presentation to the said Benefice of Wolverton, now vested in them as aforesaid, should be transferred to and be vested in the Bishop of Coventry for

the time being:

"And whereas the Right Reverend Lisle, now Bishop of Coventry, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he, the said Lisle, Bishop of Coventry, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Wolverton, which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Wolverton, otherwise Wolverdington:

"Now, therefore, with the consent of the said Guy Edward Winthrop and Edward Ashburner Manisty (in testimony whereof they have signed and sealed this Scheme), and with the consent of the said Lisle, Bishop of Coventry (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Wolverton, now vested in them, the said Guy Edward Winthrop and Edward Ashburner Manisty as aforesaid, shall be transferred to the said Lisle, Bishop of Coventry, and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Lisle, Bishop of Coventry, and by his successors in the same Bishopric for

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Coventry.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 16th and 17th years of Her late Majesty Queen Victoria, Chapter 50, and of the Act of the 23rd and 24th years of Her said late Majesty, Chapter 124, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 25th day of January, 1923, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 16th and 17th years of Her late Majesty Queen Victoria, Chapter 50, and of the Act of the 23rd and 24th years of Her said late Majesty, Chapter 124, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting an exchange of the Patronage of the Benefice (being a Rectory) of Gunhouse with Burringham, situate in the County of Lincoln and in the Diocese of Lincoln, for the Patronage of the Benefice of Waxham (being a Rectory) with the Vicarage of Palling annexed, situate in the County of Norfolk and in the Diocese of Norwich:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Gunhouse with Burringham is vested in the Bishop of Norwich for the time being:

"And whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Waxham with Palling is vested in the Bishop of London for the time being:

"And whereas the Right Reverend Bertram, now Bishop of Norwich, and the Right Honourable and Right Reverend Arthur Foley, now Bishop of London, have respectively signified to us their desire that the Patronage of the said two Benefices of Gunhouse with Burringham and Waxham with Palling may be rearranged by way of exchange in the manner which is hereinafter recommended and proposed:

"And whereas we have made due inquiry and calculation as to the circumstances and relative value of the said two Benefices and of the Patronage thereof respectively and we do hereby certify to Your Majesty in Council that the circumstances and present values of the said two Benefices are as set forth in the Schedule hereunto annexed:

"Now, therefore, with the consent of the said Bertram, Bishop or Norwich; acting as such Bishop, and with the consent of the said Arthur Foley, Bishop of London, acting as such Bishop (in testimony whereof to this Scheme the said two Bishops have respectively affixed their hands and their Episcopal Seals), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Gunhouse with Burringham and the Churches thereof shall be assigned and
