> ELECTRICITY (SUPPLY) ACTS, 1882-1922.

WOODFORD AND DISTRICT ELECTRICITY SPECIAL ORDER, 1923.

OTICE is hereby given, that the County of London Electric Supply Company Limited, whose registered office is situate at Moorgate Court, Moorgate Place, in the City of London (hereinafter called "the Company "), have applied to the Electricity Commissioners under the Electricity (Supply) Act, 1919, for a Special Order (hereinafter called "the Order") for all or some of the following amongst other purposes (that is to say):

(b) To incorporate with the Order (with or without modifications or exceptions) all or any of the provisions of the Schedule to the Electric Lighting (Clauses) Act, 1899, and the Acts and portions of Acts incorporated therewith, and to confer on the Company all such powers as may be necessary for effecting the objects of the undertaking, and to alter, vary or extinguish all rights and privileges which would or might interfere with any such objects.

2. To authorize the Company to break up and to lay electric lines over, along or under any bridge over the Great Eastern Railway.

3. The streets in which it is proposed that electric lines shall be laid down within a specified time are as follows:

In the urban district of Buckhurst Hill: Queen's Road (from King's Place

to west end of Princes Road).

In the urban district of Wanstead: High Street (from Hermon Hill to Grove Park).

In the urban district of Woodford: High Road, Woodford Green (from (from Chestnut Walk to the Terrace)

In the urban district of Loughton: High Road, Loughton (from Old Station Road to Forest Road).
