(1) The Rotherham Corporation Act; 1911, so as to authorise the Corporation to construct the service reservoir described in Section 46 of the said Act. viz.:—

Section 46 of the said Act, viz.:—

"A service reservoir to be situate upon certain lands in the Parish and County Borough of Rotherham lying to the south of and adjoining Wortley Road, being the enclosures numbered 380, 381 and 416 on the 1-2,500 Ordnance Map of the said parish (second edition, 1905), and a part of the enclosure numbered 379 on the said map, situate at the southern side there."

notwithstanding that the time limited by the said Act of 1911 for the construction of the said reservoir has expired, and to provide that the said reservoir shall be constructed within 5 years from the date of the confirmation of the Provisional Order;

(2) The Rotherham Corporation Act, 1921, so as to declare that, notwithstanding the provisions contained in Part VII. (Rating) of the said Act, the provisions relative to rating in the area added to the Borough of Rotherham by the Sheffield Corporation (Consolidation) Act, 1918, contained in Section 29 thereof, continue and shall be deemed to have continued in operation and shall apply and shall be deemed to have applied to so much of the consolidated rate as is levied for purposes for which the general district rate would have been levied if the said Act of 1921 had not been passed and

(3) For the several purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Acts or of any other Local Act or Acts confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, in force in the said Borough as may be neces-

sary or desirable:

And whereas it is proposed that a Provisional Order should be issued in compliance

with the said Application;
