#### ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 3rd March, 1923.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar-General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:—

And whereas by the Staffordshire and Worcestershire (Hunnington to Halesowen) Confirmation Order, 1922, a part of the civil parish of Hunnington, in the Bromsgrove Poor Law Union, was transferred to the civil parish of Halesowen, in the Stourbridge Poor Law Union, and it is desirable that a corresponding alteration should be made in the area of the Registration Sub-districts hereinafter mentioned:—

Now, therefore, I, Sylvanus Percival Vivian, Registrar-General of Births, Deaths and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Bromsgrove and Stourbridge Registration of Births, &c. (Alteration of Sub-districts) Order, 1923, and shall come into operation on the first day of April, 1923.

2. The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. The part of the civil parish of Hunnington, which was transferred by the recited Order to the civil parish of Halesowen, shall cease to form part of the Belbroughton Registration Sub-district of the Bromsgrove Registration District, and shall be transferred to and form part of the Halesowen Registration Sub-district of the Stourbridge Registration District.

4. The Registrar of the existing Halesowen Registration Sub-district and the Superintendent Registrar of the existing Stourbridge Registration District shall be respectively the Registrar of that Registra-

tion Sub-district and the Superintendent Registrar of that Registration District, as extended by or in consequence of this Order.

#### ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 3rd March, 1923.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar-General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:—

Now, therefore, I, Sylvanus Percival Vivian, Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Windsor Registration of Births, &c. (Alteration of Sub-districts), Order, 1923, and shall come into operation on the 1st April, 1923.

2. The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. The part of Old Windsor Civil Parish now situated in Egham Sub-district of Windsor Registration District shall be transferred to and form part of Windsor Sub-district of the same Registration District.

4. The Registrars of the existing Sub-districts of Egham and Windsor shall be the Registrars of those Sub-districts respectively as altered by this Order.
