HEREAS by treaty, grant, usage, sufferance and other lawful means His Majesty has jurisdiction within the Islands of the Pacific Ocean known as the New Hebrides including the Banks Islands and Torres Islands:

And whereas by an Order in Council bearing date the 20th day of June, 1922, and entitled The New Hebrides Order in Council, 1922 (hereinafter called the Principal Order), provision was made for the exercise of His Majesty's jurisdiction within the said Islands in accordance with the terms of a Protocol signed at London on the 6th day of August, 1914, by Representatives of the Government of His Majesty the King and the Government of the French Republic and ratified on the 18th day of March, 1922, by His Majesty's Government and the Government of the French Republic:

And whereas it has been agreed by notes exchanged between the Government of His Majesty the King and the Government of the French Republic dated the 16th day of December, 1922, and the 26th day of December, 1922, respectively, and set out in the
