IMPORTATION OF CANADIAN CATTLE ORDER OF 1923.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested' in him under the Diseases of Animals Act, 1894, and of every other power enabling him in this behalf, hereby orders as follows:—

Interpretation.

1. In this Order, unless the context otherwise requires,

"The Act of 1894" means the Diseases of Animals Act, 1894.
