## COAL MINES ACT, 1911.

THE Horses in Coal Mines (Glanders)
Order of the 12th March, 1923.

Lieut.-Colonel G. R. Lane-Fox, M.P., the Secretary for Mines, gives notice that, in pursuance of the provisions of the Mining Industry Act, 1920, the Board of Trade have made an Order under Paragraph I of the Third Schedule to the Coal Mines Act, 1911, in substitution for the Order dated 1st January, 1921, prescribing the manner in which horses shall be tested for Glanders before they are taken underground.

The new Order permits alternative tests, namely, (a) the intradermic injection of mallein (eye test), and (b) the hypodermic injection of mallein followed by the taking of the animal's temperature at specified hours (subcutaneous test) as prescribed by the Order of 1st January, 1921.

The Order applies solely to the testing of horses intended for employment below ground in mines to which the Coal Mines Act, 1911, applies, and the sanction of the intradermic (eye test) for this purpose does not prejudice in any way the provisions of any existing or future Order of the Minister of Agriculture and Fisheries in relation to Glanders or Farcy.
