THE PLACES OF ELECTION (SCOTLAND) ORDER. 1923, DATED 19TH MARCH, 1923, MADE BY THE SECRETARY FOR SCOTLAND UNDER SEC-TION 43 (16) OF THE REPRESENTATION OF THE PEOPLE ACT, 1918 (7 & 8 GEO. 5, c. 64), AMENDING THE PLACES OF ELECTION (SCOT-LAND) ORDER, 1918.

Whereas by sub-section (16) of section 43 of the above Act it is provided that, in the case of Parliamentary Elections (other than an election for a university constituency) the place of election shall be a convenient room situated in such place as the Secretary for Scotland may by order from time to time determine: •

And whereas in pursuance of this provision places of election were determined by the Places of Election (Scotland) Order, 1918 (a):

And whereas an amendment in the provisions of that Order was made by the Places of Election (Scotland) Order, 1922 (b):

And whereas certain further amendments in the provisions of the Places of Election (Scotland) Order, 1918, appear to me expedient:

Now, therefore, I, the undersigned, His Majesty's Secretary for Scotland, do hereby Order, in pursuance of my powers in that behalf, that the Schedule to the Places of Election (Scotland) Order, 1918, shall be further amended as follows:-

(1) In Part I:-

Edinburgh shall be substituted for Leith as the Place of Election for the Parliamentary Constituency of Leith.

(2) In Part II:-

(a) Airdrie shall be substituted for Glasgow as the Place of Election for the Coatbridge Division of Lanark.

(b) Hamilton shall be substituted for Glasgow as the Place of Election for the Hamilton Division of Lanark.

(c) Hamilton shall be substituted for Glasgow as the Place of Election for the Motherwell Division of Lanark.

This Order may be cited as the Places of Election (Scotland) Order, 1923.
