(Supply of Electricity in Parts of the Urban District of Wantage and the Rural District of Wantage; Laying of Electric Lines, Breaking up Streets, &c. ; Maximum Price ; Transfer of Undertaking, and Powers of Order, &c.)

PPLICATION has been made by the A Western Electric Distributing Corporation Limited, whose registered office is situate at the Electricity Offices, Cairnscross, Stroud, Gloucestershire (hereinafter referred to as "the Undertakers"), to the Electricity Commissioners, under the Electricity (Supply) Acts, 1882 to 1922, for a Special Order for the following objects:

1. To authorise the Undertakers to supply and distribute electricity for all public and

private purposes, as defined by the Electricity Supply) Acts, within so much of the Urban District of Wantage and of the Parishes of Ardington, Charlton, East Challow, East Lockinge, Grove, Letcombe Regis, West Challow and West Lockinge, in the Rural District of Wantage, as lie within a circle having for its centre the point of intersection of Garston Lane, Charlton Road, and Ormond Road, Wantage, and a radius of two miles, all in the County of Berks (hereinafter referred to as "the Area of Supply ").

Mill Street, from Letcombe Brook to Market Place; Market Place, Wallingford Street, Newbury Street, from Market Place to northern boundary of cricket field; the street leading from Market Place past the Church to Church Street; Church Street, from the last-mentioned street to Priory Road; Priory Road.

5. The streets, and parts of streets, not repairable by a local authority, and tramways which the Undertakers propose to take powers to break up are :-

(a) County Roads-

So much of the following main roads as are situate within the Area of Supply:-The road from Wantage to Oxford, the road from Wantage to Reading, the road from Wantage to Shrivenham, the road from Wantage to Hungerford, the road from Wantage to Faringdon, Ormond Road.

(b) Other Roads-

Urban District of Wantage:--Stirlings Road, Belmont Road, Willow Lane, Springfield Road.

(c) Roadways on and approaches to the following canal bridges-

(i) Bridges over the Wilts and Berks Canal.

In the Rural District of Wantage :-Grove Bridge, Barwell Bridge, Challow Bridge, Stockham Bridge.

(ii) Bridge over the Wilts and Berks Canal (Wantage Arm)-

In the Urban District of Wantage :--Belmont Bridge.

(d) Tramways— The tramways of the Wantage Tramway Company Limited.
