NOTICE is hereby given, that the Woking Electric Supply Company Limited, whose registered office is situate at Chobham Road, Woking, in the County of Surrey (hereinafter called "the Undertakers"), are applying to the Electricity Commissioners for a Special Order (hereinafter called "the Order"), under the Electricity (Supply) Acts, 1882 to 1922, for all or some of the following amongst other purposes, that is to say:—

To extend the area of supply under the Woking Electric Supply Company Electric Lighting Order, 1900, and the Woking Electric Supply Company Electric Lighting (Chertsey Extension) Order, 1905, and the Woking Electric Supply Company Electric Lighting (Extension) Order, 1908 (which said Orders are hereinafter referred to as "the Principal Orders ''), so as to include therein the Parish of Shepperton, in the County of Middlesex, and the Parish of Littleton, in the County of Middlesex, or so much thereof as is not included in the Principal Order of 1908 (that is, so much of the Parish of Littleton as is north of an imaginary line drawn from a point on the Shepperton and Littleton Parish boundary 500 yards or thereabouts north from the centre of the River Thames in a due westerly direction to the point where it joins the Laleham Parish boundary), which said parishes of Shepperton and Littleton are included in the rural district of Staines, in the County of Middlesex (the said area of supply so extended hereinafter referred to as "the extended area of supply "), and to authorize the Undertakers to supply, distribute and sell electrical energy for public and private purposes, as defined by the Electric Lighting Acts, within the Acts, within the extended area of supply.

To enable the Undertakers to exercise within the extended area of supply, with or without modification, all or some of the powers exercisable by them within their existing area of supply under the Principal Orders, including the powers to break up streets, roads and railways, and of levying and recovering rates, rents and charges for the supply of electricity and meters and apparatus, and to extend and

Ash Road (Squires Bridge Estate), Wood Road, Horne Road, Squires Road, Ash Road (near Shepperton Station), Govett Avenue, Docket Lane, Abbey Road, Crescent Road, Towing path from Littleton boundary to Shepperton Ferry, Towing path from Walton Bridge to Walton Boundary.

In the Parish of Littleton:

Towing path from Shepperton Boundary

to Chertsey Bridge.

The names of the streets and parts of streets in which it is proposed that electric lines shall be laid down within a specified time are as follows:—

In the Parish of Shepperton:-

Highfield Road from Range House to Manor House Lodge, Highfield Road from Lords Bridge to the Railway Station, Laleham Road from Shepperton Railway Station for a distance of 500 yards in the direction of Littleton; Green Lane from the railway station to Brooklands Avenue, Manygates Lane; Lower Haliford Road from Lords Bridge to the Old Manor House. In the Parish of Littleton:—

Squires Bridge Road from Laleham Road to Littleton Green.

To confer upon the Undertakers all or some of the powers of the Electric Lighting Acts, 1882 to 1922, and enactments incorporated therewith, and to alter, vary or extinguish all rights and privileges which would or might interfere with any of the objects of the Order and to confer all other rights and privileges necessary for carrying such objects into effect.
