DANGEROUS DRUGS ACT, 1920.

RE WALTER THOMAS FUGE, CHEMIST AND DRUGGIST.

Whereas, in pursuance of the powers conferred upon the Secretary of State by No. 6 of the Raw Opium Regulations, 1921, and by No. 10 of the Dangerous Drugs Regulations, 1921, the authorisations granted by the Raw Opium Regulations, 1921, and the Dangerous Drugs Regulations, 1921, to persons who lawfully keep open shop for the retailing of poisons in accordance with the provisions of the Pharmacy Act, 1868, as amended by the Poisons and Pharmacy Act, 1908, to be in possession of and supply raw opium and to carry on the business of manufacturing, selling or distributing the drugs to which Part III of the Dangerous Drugs Act, 1920, applies, were, by notice dated 7th June, 1922, and published in the London Gazette on 16th June, 1922, withdrawn from Walter Thomas Fuge, of 3, White Hart Street, High Fuge, of 3, White Hart Street, High Wycombe, who had been convicted of an offence against the Dangerous Drugs Act,

And whereas the said Walter Thomas Fuge has applied, and the Pharmaceutical Society of Great Britain has recommended, that the said authorisations may now be restored to him.

Now, therefore, I hereby suspend until further order the operation of the notice of withdrawal of the said authorisations from the said Walter Thomas Fuge.
