And whereas by the said Act it is amongst other things provided that where His Majesty is satisfied that reciprocal provisions have been made by the Legislature of any part of His Majesty's dominions outside the United Kingdom for the enforcement within that part of His dominions of judgments obtained in the High Court in England, the Court of Session in Scotland, and the High Court in Ireland, His Majesty may by Order in Council declare that the said part of that Act shall extend to that part of His dominions and that on any such Order being made the said part of that Act shall extend accordingly:

And whereas by the said Act it is further provided that His Majesty may by Order in Council declare that the said part of that Act shall apply to any territory which is under His Majesty's protection, or in respect of which a mandate is being exercised by the Government of any part of His Majesty's dominions, as if that territory were part of His Majesty's dominions, and that on the making of any such Order the said part of that Act shall, subject to the provisions of the Order, have effect accordingly:

And whereas on the 6th day of December, 1922, the Irish Free State was established under the provisions of an Act of Parliament shortly entitled the Irish Free State Constitution Act, 1922 (Session 2):

And whereas His Majesty is satisfied that the Legislatures of the territories which are under His Majesty's protection hereinafter mentioned have made reciprocal provisions for the enforcement within those territories of judgments obtained in the High Court in England, the Court of Session in Scotland, and the High Court in Ireland:

Now, therefore, His Majesty, by virtue and in exercise of the powers by the above-recited Act in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

1. Part II. of the Administration of Justice Act, 1920, shall extend to the territories under His Majesty's protection hereunder mentioned :---

The Protectorate of Kenya. Southern Rhodesia.

2. Nothing in this Order shall affect the registration or enforcement in the Irish Free State of any judgment in pursuance of Part II. of the said Act.

And the Most Noble the Duke of Devonshire, K.G., G.C.M.G., G.C.V.O., one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

Navy.—Officers, R.N., R.N.R., and R.N.V.R., in possession of Full Dress Uniform—No. 1 Dress (Full Dress). Officers, R.N., R.N.R., and R.N.V.R., not in possession of Full Dress Uniform-No. 3 Dress (Frock Coat with Epaulettes).

Army.—Officers in possession of Full Dress of their rank—Levée Dress.

Officers not in possession of Full Dress Uniform of their rank—Service Dress.

Air Force.—Officers in possession of Full Dress Uniform—Full Dress.

Officers not in possession of Full Dress Uniform-Service Dress.

The following are the Regulations to be observed :---

1. Gentlemen who have been presented and who wish to attend a Levée, should make a written application, as detailed below.

2. Peers, Bishops, His Majesty's Lieutenants of Counties, Deputy Lieutenants of Counties, Members of Parliament, Officials connected with the Houses of Parliament, Clergy of all Denominations, and all gentlemen other than those mentioned hereafter, should communicate with the Comptroller, Ceremonial Department, St. James's Palace. No applications can be received from gentlemen in the foregoing categories wishing to be presented. Their names must be forwarded by the gentleman making the presentation.

3. All Officers, whether on the active or retired lists of the Royal Navy and the Royal Marines, will communicate with and obtain their cards, whether for attendance or presentation, from the Private Secretary to the First Lord of the Admiralty.

4. All Officers, whether on the active or retired lists of the Army, except Officers of the Household Cavalry and the Brigade of Guards, and those on the Indian and Colonial Establishments, will communicate with and obtain their cards, whether for attendance or presentation, from the Secretary, War Office. Officers of the Household Cavalry and the

Officers of the Household Cavalry and the Brigade of Guards will communicate, through their Regimental Headquarters, with the Comptroller, Ceremonial Department, St. James's Palace, to obtain their cards for attendance or presentation.

5. All Officers of the Royal Air Force, whether on the active or retired lists, will communicate with and obtain their cards, for attendance or presentation, through the usual channels.

6. All Officers of the Indian Civil Service and of the Indian Army, whether on the active or retired lists, will communicate with and obtain their cards, for attendance or for presentation, from the Private Secretary to the Secretary of State at the India Office, Whitehall.

7. All Officers of the Colonial Service and Colonial Forces, whether on the active or retired lists, will communicate with and obtain their cards, whether for attendance or presentation, from the Colonial Office, Whitehall, with the exception of Officers of the local Forces of the self-governing Dominions, who will apply to the Secretary, War Office, for their cards for attendance or for presentation, supporting their application in all cases by a credential from the Governor-General, Governor, Officer commanding the local Forces, or the representative in London of the Dominion concerned.
