testimony whereof he has hereunto set his hand), and with the consent also of the Dean and Chapter of the Cathedral Church of Christ and the Blessed Mary the Virgin of Worcester as the Patrons of the said Benefice of Cropthorne (in testimony whereof they have caused their Common or Corporate Seal to be affixed hereto), do humbly recommend and propose to Your Majesty as follows, that is to say:

"1. That the said Benefice of Cropthorne and the said Benefice of Saint John the Evangelist, Charlton, shall be permanently united together and form one Benefice with cure of souls under the style of 'The United Benefice of Cropthorne with Charlton,' but the Parishes of the said Benefices shall continue distinct in

all respects.
"2. That upon the day when any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette the union shall forthwith take effect, and the said Herbert Wilkinson if he is then Incumbent of the said Benefice of Cropthorne shall be the first Incumbent of the United Benefice.

"3. That upon the said union taking effect the Parsonage House at present belonging to the said Benefice of Cropthorne shall become and be the house of residence for the Incum-

bent of the United Benefice.

- "4. That after the said union has taken effect a portion amounting to £150 per annum of the yearly sum or stipend of £246 2s. 6d. per annum at present payable by us, the said Ecclesiastical Commissioners, to the Incumbent for the time being of the said Benefice of Cropthorne shall be excepted out of the union and shall be transferred and annexed in equal shares of £50 per annum to each of the three Benefices of (1) Birlingham with Nafford, (2) Kempsey, and (3) Saint Peter the Great, Worcester, all situate in the said Diocese of Worcester, such transfer and annexation to take effect as from the date of the avoidance of the United Benefice by the said Herbert Wilkinson.
- "5. That after the said union has taken effect the course and succession in which the respective Patrons shall present or nominate to the United Benefice from time to time as the same shall become vacant shall be as follows, that is to say, that in each series of three successive turns of presentation or nomination for ever thereafter the Patrons of the said Benefice of Cropthorne shall have the first and third turns and the Patron of the said Benefice of Saint John the Evangelist, Charlton, shall have the second turn

"Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of

any other Act of Parliament.'

And whereas drafts of the said Scheme have been published locally in the manner prescribed in the Statutory Rules made under the said Act and also transmitted in the manner so prescribed to the Patrons affected, together with a Notice in each case requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the same Rules:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Worcester has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas neither of the two Benefices affected by the said Scheme is situate in a City

or Municipal Borough:

And whereas the said Scheme has been

approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the two Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the . said Scheme, and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Worcester.
