1923, in the words and figures following, that is to say:---

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure of Blackwell and the Church and Cure of Marston upon Dove, both in the County of Derby and in the Diocese of Southwell, which said Churches and Cures are hereinafter referred to as the said Benefices of Blackwell and Marston upon Dove:

"Whereas the Advowson or perpetual right of Patronage of and presentation to each of the said Benefices of Blackwell, and Marston upon Dove, is vested for an estate in fee simple without incumbrances in the Most Noble Victor Christian William, Duke of Devonshire, K.G.:

"And whereas the said Victor Christian William, Duke of Devonshire, is desirous that the whole Advowson or perpetual right of Patronage of and presentation to each of the said Benefices of Blackwell, and Marston upon Dove, now vested in him as aforesaid, should be transferred to and be vested in the Bishop of Southwell for the time being:

"And whereas the Right Reverend Edwyn, now Bishop of Southwell, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he, the said Edwyn, Bishop of Southwell, has executed this Scheme as hereinafter mentioned :

"And whereas the transfer of the Patronage of each of the said Benefices of Blackwell, and Marston upon Dove, which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parishes or Districts in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parishes of Blackwell, and Marston upon Dove:

"Now, therefore, with the consent of the said Victor Christian William, Duke of Devonshire (in testimony whereof he has signed and sealed this Scheme), and with the consent of the said Edwyn, Bishop of Southwell (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to each of the said Benefices of Blackwell, and Marston upon Dove, now vested in him, the said Victor Christian William, Duke of Devonshire, as aforesaid, shall be transferred to the said

Edwyn, Bishop of Southwell, and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Edwyn, Bishop of Southwell, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Southwell.

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme or Representation for altering the boundaries of the New Parish of Saint Mary, Disley, in the County of Chester and in the Diocese of Chester:

"Whereas by the authority of an Order of Your Majesty in Council bearing date the 14th day of October, 1913, and published in the London Gazette on the same day, part of the Parish of Saint Mary in Stockport, in the said County of Chester and in the said Diocese of Chester, was assigned as a District Chapelry to the consecrated Church of Saint Mary the Virgin, situate at Disley, in the said Parish of Saint Mary in Stockport, and the said District Chapelry was named 'The District Chapelry of Saint Mary, Disley':
