Not exceed 50,000 gallons, at a rate not exceeding 2s. 3 3-5d. per 1,000 gallons.

Exceed 50,000 but not 500,000 gallons, at a rate not exceeding 1s. 8 7-10d. per 1,000 gallons.

Exceed 500,000 gallons, at a rate not exceeding 1s. 1 4-5d. per 1,000 gallons, with a minimum charge of 5s. 9d. in any quarter of a year.

Such rates are an increase of 15 per centum on the rates prescribed by Section 27 of the said Act of 1909.

(b) The rate for other than domestic purposes outside the borough shall not exceed No. 32834. B by more than  $13\frac{1}{3}$  per centum the corresponding charge under similar circumstances within the borough as provided by Section 26 of the said Act of 1909.

(c) The rate for supplies to public baths within the borough shall be 5<sup>3</sup>/<sub>4</sub>d., and outside the borough 6 9-10d. per 1,000 gallons.

Such rates are an increase of 15 per centum upon the rates prescribed by Section 110 of the said Act of 1909.
