and the Railway within the extended area of supply which the Undertakers propose to take special powers by the Order to break up:—

In the Parish of East Bedfont: ---

Reedsfield Road, the roadway on the bridge carrying Clockhouse Lane over the Southern Railway.

In the Parish of Hanworth: -

New Road, Milbourne Road, Raleigh Way, Elizabeth Way, the roadway on the bridge carrying the road near Kempton Park Racecourse over the Southern Railway (Thames Valley Line).

In the Parish of Shepperton:-

Ash Road (Squire Bridge Estate), Wood Road, Horne Road, Squire's Road. Ash Road (near Shepperton Station), Station Road, Govett Avenue, footpath from Backfields Road to Manygates Lane, Dockett Eddy Lane, Park Road, Abbey Road, road unnamed opposite Sheep Walk in Chertsey Road, Crescent Road, towing path from Littleton boundary to Shepperton Ferry.

In the Parish of Harlington: -

Bournes Bridge over the Great Western Railway.

The names of the streets and parts of streets in the extended area of supply in which it is proposed that electric lines shall be laid down within a specified time are as follows:—

In the Parish of East Bedfont:

Staines Road from Fagg's Road to Bedfont House, Hatton Road from Bedfont House to the Two Bridges, Fagg's Road, Hatton Road from Fagg's Road to Harlington parish boundary, New Road, High Road.

In the Parish of Hanworth: -

Twickenham Road from Holland Lodge to Bridge over Longford River, Bear Road, Sunbury Road, Hounslow Road from Holland Lodge to The Mount, Hanworth Road from The Mount to Feltham urban district boundary Main Street from Nallhead Road to Bear Road.

In the Parish of Shepperton. -

Sheep Walk from Pool End to St. John's Church, Green Lane, Broadlands Avenue, Manygates Lane, Backfields Road, Laleham Road, Highfield Road from Station to Range House, Charlton Road from Station to Sunbury-on-Thames urban district boundary, Watersplash Road from Lords Bridge to Sunbury-on-Thames urban district boundary.

To confer upon the Undertakers all or some of the powers of the Electric Lighting Acts, 1882 to 1922, and enactments incorporated therewith, and to alter, vary or extinguish all rights and privileges which would or might interfere with any of the objects of the Order, and to confer all other rights and privileges necessary for carrying such objects into effect.

Every local or other public authority, company or person being desirous of bringing before the Electricity Commissioners any objection respecting the Application must do so by registered letter, addressed to the Secretary, Electricity Commission, Gwydyr House, Whitehall, London, S.W. 1, and despatched on or before the 7th day of September, 1923, and a copy of such objection must also at the same time be forwarded to the undersigned Solicitors and Parliamentary Agents.
