

Chepstow Villas, in two portions, and do make the following Regulations with regard to the Boundaries for the same, viz. :—

First Portion.—Three Carriages at Westbourne Grove, in centre of roadway, commencing opposite entrance to Bonaparte Mansions, extending Westward as far as necessary for three carriages.

Front of vehicles toward the East.

Second Portion.—Nine Carriages at Chepstow Villas, in centre of roadway, commencing immediately behind lamp-post at junction with Pembridge Villas, extending Westward as far as necessary for nine Carriages.

Front of vehicles toward the East.

The first portion of the Standing to be fed exclusively by Carriages from the second portion.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriageway, or upon any place where foot passengers usually cross the carriageway.
