ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 14TH SEPTEMBER, 1923.)

IRISH ANIMALS (MARKING) ORDER OF 1923 (No. 2).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:-

Marking of Irish Animals.

1.—(1) Cattle brought from Ireland shall not be moved from a reception lair in a landing place approved by the Minister for the purposes of the Animals (Landing from Ireland, Channel Islands, and Isle of Man) Order of 1923, unless and until the cattle have been marked at the expense of the owner or his agent in the following manner, namely:

By fixing to the left ear of each cattle a numbered tag of a pattern approved by the
