PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR FEMALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated respectively 31st October, 1918 and 1st August, 1922, the Trade Board established in England and Wales under the Trade Boards Act, 1918, for the Hat, Cap and Millinery Trade as specified in the Trade Boards (Hat, Cap and Millinery) Order, 1919, HEREBY GIVE NOTICE as required by Section 3 (5) of the Trade Boards Act, 1918, that THEY PROPOSE TO VARY the General Minimum Time-Rates for Female Workers other than Learners, the Piece-Work Basis Time-Rates for all Female Workers, the Overtime Rates for Female Workers (other than Learners) employed on Time-Work and the Overtime Rates for all Female Workers employed on Piece-Work, as set out in Parts I, II and III of the Schedule to the Trade Board's Notice H.M.
