TRADE BOARDS ACTS, 1909 AND 1918.

TOBACCO TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO CANCEL THE PROVISION EXCLUDING FROM THE OPERATION OF MINIMUM RATES MALE OR FEMALE LEARNERS TO HAND OR MOULD CIGAR MAKING DURING THEIR FIRST 12 MONTHS OF LEARNERSHIP, AND TO VARY CERTAIN CONDITIONS ATTACHED TO THE MINIMUM RATES OF WAGES FOR MALE AND FEMALE APPRENTICES IN THE CIGAR SECTION OF THE TRADE.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October, 1918, and 1st August, 1922, the Trade Board established under the Trade Boards Act, 1918, for the branches of the trade specified in the Trade Boards (Tobacco) Order, 1919, HEREBY GIVE NOTICE, as required by Section 3 (5) of the Trade Boards Act, 1918, that they PROPOSE TO FIX General Minimum Time-Rates and Overtime Rates for Male and Female Learners to Hand or Mould Cigar Making during the first 12 months of their Learnership, and to vary the minimum rates of wages for certain classes of male and female apprentices in the Cigar Section of the trade by varying certain of the conditions specified in Part IV of the Schedule to the Trade Board's Notice N. (8), dated 31st August, 1921, the Board's proposals being as shown in the Schedule set out below.
