BOOT AND SHOE REPAIRING TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY AND FIX MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS FOR PERIODS DEPENDENT UPON THE COST OF LIVING FIGURE.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated respectively 31st October, 1918, and 1st August, 1922, the Trade Board established under the Trade Boards Act, 1918, in Great Britain, for the branches of Trade specified in the Trade Boards (Boot and Shoe Repairing) Order, 1919, hereby give notice as required by Section 3 (5) of the Trade Boards Act, 1918, that they propose to vary (the Minister of Labour having given his consent to such Notice being given) the General Minimum Time-Rates. Guaranteed Time-Rates, General Minimum Piece-Rates and Overtime Rates at present effective and set out in the Trade Board's Notices D. (19), D. (20), and D. (21), dated 23rd August, 1922, and that they propose to Fix certain General Minimum Piece Rates and Male for Female Overtime Rates and Workers, the proposed rates to be operative for periods dependent upon the Cost of Living Figure.

The 'Trade Board will consider any objections to the above proposals which may be lodged with them within two months from the 9th day of October, 1923. Such objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Boot and Shoe Repairing Trade Board (Great Britain), 1, Whitehall Gardens, London, S.W. 1.

It is desirable that the objections should state precisely, and so far as possible, with reasons, what is objected to.
