jurisdiction of courts is suspended until His Majesty, by and with the advice of his Privy Council, shall otherwise order, in such portions of the Ottoman Dominions as may be subject to the military occupation of Great Britain or of an Allied Power or Powers, provided that courts have been established therein by the occupying Power or Powers which are recognised by His Majesty as competent to exercise jurisdiction over British subjects and their property and over British ships;

And whereas by Article 3 (2) of the said Turkey Order-in-Council, 1922, it is provided that the Secretary of State shall from time to time give notice of any such suspension of the said Ottoman Order-in-Council, 1910, and shall specify the areas within which such suspension shall operate;

Now, therefore, I, George Nathaniel, Marquess Curzon of Kedleston, K.G., &c., &s., &c., His Majesty's Principal Secretary of State for Foreign Affairs, hereby give notice that the operation of so much of the Ottoman Order-in-Council, 1910, as relates to the power and jurisdiction of courts is suspended in Syria within the boundaries of the area under French mandate.
