BOGNOR.

Whereas the Urban District Council of Bognor have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, to partially repeal, alter or amend the Local Acts 3 Geo. IV, ch. lvii, 6 Geo. IV, ch. cxxxv, and 5 and 6 Will. IV, ch. ci, as amended by the Local Government Supplemental Act, 1867 (No. 5), and by certain Provisional Orders made by the Local Government Board and duly confirmed by Parliament so as:—

(1) To abolish the right to hold an open and public market for the sale of marketable commodities in the building known as the Market House and situate in the Steyne, Bognor, and a market place in connection therewith and the fences, erections, sheds, stalls and all other parts thereof, the holding of which said market was authorised under the provisions of the said Local Act 3 Geo. IV, ch. lvii.

(2) To empower the Council to utilize the said Market House, market place, and the said fences, erections, sheds, stalls, and all other parts thereof for other purposes than as a market, and if thought fit, to alter, convert, pull down or demolish the said Market House, market place, and the said fences, erections, sheds, stalls and all other parts thereof, and to erect or continue thereon lavatories, baths, shops and such other buildings, erections or things as may be authorized under the Public Health Acts, or any of the Acts incorporated therewith.

(3) To let or sell the said Market House, market place, and the said fences, erections, sheds, stalls and all other parts thereof to any person for any other purpose than that of a market.

(4) To confer on the Council any borrowing powers necessary for the purpose of the Provisional Order and to make provision for sinking funds and re-borrowing of moneys.

(5) To enable the Council to prohibit the sale of goods, playing of musical instruments, delivering of lectures or sermons, holding of religious services, taking of photographs, or the exercise of any other trade or calling on the seashore and foreshore belonging to them.

(6) To repeal certain provisions of the said Local Acts and Provisional Orders in force in the District, and to re-enact, with or without modifications, certain of those provisions, including those with respect to sea-defence works and the licensing of bathing machines; and for the several purposes of this application, or for purposes connected with, incidental to, or consequent on, those purposes to make any such alteration or amendment of the said Local Acts or of any other Local Act, or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the District as may be necessary or desirable.

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application;
