# PART III.

## APPLICATION OF THE MINIMUM RATES.

SECTION I.

The minimum rates of wages specified in this Schedule apply, subject to the provisions of the Trade Boards Acts, to all Male Workers under 21 years of age in Great Britain, in respect of all time during which they are employed in any branch, other than the Scrap Metal Branch (as defined in Section II of this part) of the General Waste Branch of the Waste Materials Reclamation Trade, as defined in the Regulations made by the Minister of Labour, dated 27th August, 1920, and set out in Part IV of the Schedule to the Trade Board's Notice D.B. (7), dated 30th January, 1923.

## SECTION II.

For the purpose of this Notice the Scrap Metal Branch of the Trade is that branch of the Trade specified in Part IV of the Schedule to the Trade Board's Notice D.B. (7), which is engaged in the collecting, sorting, grading, or breaking of scrap iron or other scrap metal, where the collecting, sorting or grading of other waste materials is not carried out to a substantial extent in connexion therewith.

#### SECTION III.

Notwithstanding anything contained in this Notice the above Minimum Rates shall nor apply to Male Workers who are engaged in the loading or discharging of water-borne craft in any Section of the Trade.

#### PART IV.

## GENERAL PROVISIONS.

### SECTION I

The above minimum rates of wages must be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any Superannuation or other Provident Fund.

#### SECTION II

The above minimum rates of wages are without prejudice to workers who are earning higher rates of wages or to agreements made or that may be made for the payment of wages in excess of the minimum rates

Signed by Order of the Trade Board and in pursuance of an Order of the Minister of Labour confirming the Minimum Rates of Wages as fixed by the Trade Board and set out above and specifying the 19th November, 1923, as the date from which they should become effective.
