The boroughs of Harrogate, Doncaster, Keighley, Pudsey, Batley, Brighouse, and Todmorden, the petty sessional divisions of West Staincliffe (including its detached part but excluding the parishes of Litton, Halton Gill, Horton in Ribblesdale, Swinden, Nappa, and Newsholme), East Staincliffe (except the parishes of Calton, Flasby-with-Winterburn, Eshton, Stirton-with-Thorlby, Buckden, Kettlewell-with-Starbotton, Coniston Cold, Gargrave, Broughton, Elslack, Hornton-in-Craven, Earby, Salterforth, Barnoldswick, Brogden, and its detached part, Bracewell, Martons Both and Bank Newton), Otley, Keighley, Kirkby Malzeard, Claro, Ripon Liberty (including its detached parts, but excluding the parishes of Bridge Hewick, Copt Hawick, Sharow, Nunwick-with-Howgrave, Clothholme, Sutton Grange, and North Stainley-with-Slensingford), Eastern Ainsty, Lower Barkston Ash (except its detached part, and the parish of Ryther-cum-Ossendyke), Lower Osgoldcross, Lower Strathforth and Tickhill, Upper Strathforth and Tickhill, Staincross (except the parishes of High Hoyland, Kexborough, Darton, Woolley, Notton, Royston, Carlton, Shafton, South Hiendley, Hevercroft-with-Cold Hiendley, Ryhill, and Wintersett), Saddleworth, Upper Agbrigg, Dewsbury, East Morley (except the parish of Drighlington), West Morley, Todmorden and the detached part of the petty sessional division of Upper Barkston Ash, and the parishes of Lawkland, Rawdon, Horsforth, Adel-cum-Eccup, Alwoodley, Weardley, Duneswick, Kirkby Overblow, Spofforth-with-Stockeld, Little Ribston, North Deighton, Kirk Deighton, Cowthorpe, Bickerton, Bilton, Tockwith, Long Marston, Hutton Wandesley, Angram, Emley, Flockton, Gisburn Forest, Paythorne, Bolton by Bowland (including its detached part), Sawley (excluding its detached part), and Grindleton, and the detached part of the parish of Gisburn.

The petty sessional divisions of Ouse and Derwent, and Howdenshire, such portions of the petty sessional division of Wilton Beacon as lies to the south west of the railway from Market Weighton to York, via Pocklington, and the parishes of Everingham, Harswell, Holme-upon-Spalding Moor, Seaton Ross, Foggathorpe, Laytham, Harlthorp, Aughton, Ellerton Priory and East Cottingham.

*In the Administrative County of Lancaster.*

The boroughs of Colne and Nelson and The parishes of Chatburn, Worston, Mearley, Downham, Twiston, Barley with Wheatley Booth, Goldshaw Booth, Old Laund Booth, Brierfield, Wheatley Carr Booth, Roughlee Booth, Barrowford, and Trawden, and the detached part of the parish of Foulridge.
