8. The incorporation application repeal and amendment of Acts both general and local.

As regards the parish of Vaynor with the Clerk to the Vaynor Parish Council at his office at 14, Pontycapel Road, Cefn-Coed and with the Clerk to the Vaynor and Penderyn Rural District Council at his office at Merthyr Tydfil.

As regards the borough of Merthyr Tydfil with the Town Clerk of that borough at his office therein.

As regards the urban district of Gelligaer with the Clerk to the Gelligaer Urban District Council at his office at Hengoed.

As regards the urban district of Mountain Ash with the Clerk to the Mountain Ash Urban District Council at his office at Mountain Ash.

As regards the urban district of Pontypridd with the Clerk to the Pontypridd Urban District Council at his office at Pontypridd.
