The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Ânimals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:

The several premises mentioned in the Schedule hereto are hereby declared to be places infected with Foot-and-Mouth Disease.



In witness whereof the Official Seal of the Minister of Agriculture and Fisheries is hereunto affixed this twenty-first day of December, nineteen hundred and twentythree.

SCHEDULE.

Description and Limits of Infected Places.

1. The whole of the farm buildings and the fields known as The Farm, in the occupation of Manning, in the Oswald parish of Cholmondeley, in the administrative county of Chester.

2. The buildings and the fields known as High Ash Farm, together with Ridley Field, in the occupation of Mrs. Elizabeth Dobson, in the parish of Acton, in the administrative county of Chester.

3. The buildings and the lands known as The Bridge, in the occupation of George Wilkinson, in the parish of Sparstow, in the administrative county of Chester.

4. The buildings and the land known as The Barracks, in the occupation of James Sheen, and of John Vickers, in the parish of Bunbury, in the administrative county of Chester.
