The borough of Evesham;

The petty sessional divisions of Upton-on-Severn, Malvern, Evesham (including its detached parts), and Pershore; and

The parishes of Stoulton, Norton Juxta Kempsey, Whittington, St. Peter the Great County (including its detached part), Kempsey, Powick, Bransford, St. John in Bedwardine County, North Claines, St. Martin County, Martin Hussingtree, Hindlip, Warndon, Tibberton, Bredicot, Spetchley, White Ladies Aston, Churchill, Upton Snodsbury, Broughton Hackett, Crowle, Huddington, Himbleton, Oddingley, Hadzor, Hanbury, Stock and Bradley, Inkberrow, and Feckenham, and also the parishes of Childs Wickham, Aston Somerville, and Hinton-on-the-Green transferred from the county of Gloucester.

*In the administrative county of Warwick.*

The petty sessional division of Alcester (*except the parishes of Ipsley, Studley, and Morton Bagot*); and

The petty sessional divisions of Clum and Purslow, Lower Munslow, Burford, Cleobury Mortimer, Brimstree, Shifnal, Wellington, Conover, Pontesbury and Upper Munslow; and

The parishes of Uffington, Upton Magna, Ford, Alberbury with Cardeston and Wollaston (including its detached part), and such part of the parish of St. Alkmond as lies to the south of the road No. 5062, together with the said road in so far as it divides the said parish.
