BRIGHTON INTERCEPTING AND OUT-FALL SEWERS BOARD.

Whereas the Mayor, Aldermen, and Burgesses of the respective Boroughs of Brighton and Hove being the Urban Sanitary Authorities for the said Boroughs, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Brighton Intercepting and Outfall Sewers Act, 1870, the Hove Commissioners Act, 1873, and the Brighton and Hove (Outfall Sewers) Orders, 1888 and 1898, and the Acts confirming those orders, respectively, so as:-

- (1) To empower the Brighton Intercepting and Outfall Sewers Board (hereinafter called the Board) to construct and maintain at Portobello in the Parish of Telscombe, within the Rural District of Newhaven, an outfall sewer, a sea defence wall and other works, including pumping plant, to make and maintain all necessary subsidiary and ancillary works and conveniences as may be necessary for the purposes of the Board; and to purchase and use electricity for the purpose of pumping sewage and other purposes of the Board;
- (2) To empower the Board to purchase or. take on lease by agreement additional lands and to enlarge and extend the powers of the Board with reference to the holding, user, sale, lease and disposition of lands or interests in lands;
- (3) To empower the Board to borrow an additional sum of £120,000, and with the

consent of the Ministry of Health, such further sums as may from time to time be required by the Board;

- (4) To empower the Board to use the moneys in any Sinking Fund maintained by them in exercise of any borrowing power of the Board, and to confer upon the Board all such powers as may be necessary in connection with the borrowing, re-borrowing, application and repayment of moneys;
- (5) To make provision for the payment by the Board of the costs, charges and expenses of obtaining the proposed Order and of carrying into execution the powers and provisions of the Order, and for the apportion-ment of such costs, charges and expenses between constituent authorities;
- (6) To adapt and make applicable to the present Boroughs of Brighton and Hove and to the Councils of such Boroughs the provisions of the Act of 1870 and Orders of 1888 and 1898 with reference to the constitution of the Board and the representation of the constituent authorities thereon, and to reduce the number of members of the Board, and to make further provision as to the appointment of members and Auditors, and as to the inclusion of new constituent authorities for the whole or part of a district:
- (7) To make applicable the provisions of Sections 176, 297, 298 and 303 of the Public Health Act, 1875, and Sections 16 and 17 of the Public Health Acts Amendment Act, 1890;
- (8) For the several purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Acts and Orders or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the Borough of Brighton or the Borough of Hove as may be necessary or desirable;

And whereas the Mayor, Aldermen and Burgesses of the Borough of Brighton have also made application to have conferred upon the Board the powers of Section 18 of the Public Health Act, 1875;

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Applications;

Notice is hereby given that W. M. Cross, Esq., M.Inst.C.E., one of the Inspectors of the Ministry of Health, will attend at the Town Hall, Brighton, on Tuesday, the fifteenth day of January, 1924, at quarter to twelve o'clock in the forenoon, to hold a Local Inquiry into the subject-matter of the said Application and the proposed Provisional Order.

And notice is hereby further given that any person interested may attend at such Inquiry and be heard with reference to the said Application and the proposed Provisional Order.
