And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Hereford.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, duly prepared, and laid before His Majesty in Council, a Scheme or Representation, bearing date the 20th day of December, 1923, in the words and figures following, that

is to say:—
"We, the Ecclesiastical Commissioners for the provisions of the England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme or Representation for altering the boundaries of the New Parish of Headless Cross, situate partly in the County of Warwick and partly in the County of Worcester

and wholly in the Diocese of Worcester:

"Whereas by the authority of an Order of Her said late Majesty in Council, bearing date the 8th day of January, 1850, and published in the London Gazette on the 11th day of the same month, a Consolidated Chapelry was assigned to the consecrated Church of Saint Luke, situate at Headless Cross, in the Parish of Ipsley, in the said Counties of Warwick and Worcester and in the said Diocese of Worcester, and the said Consolidated Chapelry was called 'The Consolidated Chapelry of Headless

Cross ':

" And whereas the said Consolidated Chapelry of Headless Cross has under the provisions of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, become a New Parish of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and by the above-mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said New Parish of Headless Cross should be altered in the manner which

is hereinafter mentioned:
"Now, therefore, with the consent of the Right Reverend Ernest, Bishop of Worcester (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend, and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your

Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parish of Headless Cross, shall be altered so that (firstly) all those portions of the Parish of reckenham, in the said County of Worcester and in the said Diocese of Worcester, of the said Parish of Ipsley, and of the Parish of Redditch, in the said County of Worcester and in the said Diocese of Worcester, which are described in the First Schedule hereunder written and are delineated and set forth upon the map or plan hereunto annexed and are thereon coloured pink shall be dissevered from such Parishes and shall be annexed to and shall in future form part of the said New Parish of Headless Cross; and (secondly) all that portion of the said New Parish of Headless Cross which is described in the Second Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured green shall be dissevered from such New Parish and shall be restored to and shall in future form part of the Parish of Tardebigge, in the said County of Worcester and in the said Diocese of Worcester.

"And we further represent, recommend, and propose that nothing herein contained shall prevent us from representing, recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them, or of any

other Act of Parliament.

THE SCHEDULES to which the foregoing Scheme or Representation has reference.

" The First Schedule.

"The territory to be annexed to the New Parish of Headless Cross, situate partly in the County of Warwick and partly in the County of Worcester and wholly in the Diocese of

Worcester, comprising:—
"1. All that portion of the Parish of Feckenham, in the said County of Worcester and in the said Diocese of Worcester, which is bounded upon the east partly by the Parish of Coughton, in the said County of Warwick and in the Diocese of Coventry, and partly by the Parish of Ipsley, situate partly in the said County of Warwick and partly in the said County of Worcester and wholly in the said Diocese of Worcester, upon the north-east and upon the north by the said New Parish of Headless Cross, and upon the remaining sides, that is to say, upon the west, upon the southwest and upon the south by an imaginary line commencing upon the boundary which divides the said New Parish of Headless Cross from the said Parish of Feckenham at a point in the middle of Walkwood Lane opposite to the middle of the footpath leading from Grinsty Farm, and extending thence south-westward along the middle of Walkwood Lane for a distance of 7½ chains or thereabouts to a point opposite to the middle of the footpath leading into Love Lane near its junction with Dirty Lane, and extending thence first southward and then south-eastward along the middle of the last mentioned footpath for a distance of $16\frac{1}{2}$ chains or thereabouts to the point where such footpath meets Love Lane, and extending thence first southward to and then first north-westward and ${f then}$ south-westward
