*Description and Limits of Infected Places.*

The following premises in the administrative county of Chester:—

1. The farm buildings and the adjoining pastures known as Lane End Farm, in the occu-

pation of John Lawrence, in the parish of Lower Kinnerton.

2. All the fields and farm buildings on the premises in the occupation of Joseph Smith. Brindley Fields, in the parish of Nantwich.

3. All the premises and fields situated at Crimes Lane, in the occupation of J. T. Barnes, in the parish of Beeston.

4. The whole of the fields and buildings known as Doglane Farm, in the occupation of James Cooper, in the parish of Oldcastle.

5. All the premises and land comprising Brook House, in the occupation of Henry Norcross, in the parish of Malpas.

6. The fields known as Top Field, Bankey Cumbers, and Little Meadow, being part of Pitts Farm, in the occupation of Martha Huxley, in the parish of Cuddington.

7. The fields and buildings known as Stonehouse Farm, in the occupation of Dutton Bros., in the parish of Peckferton.

8. All those fields and premises in the joint occupation of George Hill and Frederick Thelwell, Bunbury Lock, in the parish of Tilstone.

10. All those fields and farm premises known as Ridley Hill Farm, in the occupation of William Twiss, in the parish of Ridley.
