**TRADE BOARDS ACTS, 1909 AND 1918.**

Whereas the Trade Boards Acts, 1909 and 1918, have been applied to the Stamped or Pressed Metal Wares Trade by the Trade Boards (Stamped or Pressed Metal Wares) Order, 1919, and to the Button-making trade by the Trade Boards (Button-making) Order, 1919;

And whereas the Minister of Labour on 28th day of February, 1924, published Notices of his intention to make Special Orders varying the description of the said trades;

And whereas objections have been made with respect to the draft Special Orders accompanying the said Notices and these objections have been considered by the Minister and he has not amended or withdrawn the draft Special Orders but has directed that an Enquiry shall be held in accordance with the First Schedule to the Trade Boards Act, 1918;

And whereas the Minister has appointed me, the undersigned, to hold the Enquiry and to report to him;

Now, therefore, I hereby give notice that an Enquiry under the First Schedule to the Trade Boards Act, 1918, with regard to the said draft Orders will be opened by me at the hour of 11.30 a.m. on Tuesday, the 6th day of May, 1924, at the Council House, Birmingham, and will be held thereafter at such time and place as may be found convenient. Any objector or other person who appears to me to be affected may appear either in person or by Counsel, Solicitor, or Agent. Any person desiring to be heard who has not already communicated in writing with the Minister of Labour should send to me in writing, as early as possible and in any event so as to reach me not later than Friday, 2nd May, 1924, a summary of the representations which he desires to make.

Shinwell, M.P., Secretary for Mines, has appointed Mr. Harold John Finney to be a Junior Inspector of Mines under the Coal Mines Acts, 1887 to 1919, and has instructed him to act also as an Inspector for the purposes of the Metalliferous Mines Regulation Acts, 1872 and 1875, and of the Quarries Act, 1894.

Under the provisions of the Mining Industry Act, 1920, and of the Factory and Workshop Act, 1901, Mr. Shinwell has further appointed Mr. Finney to be an Inspector of Factories and Workshops for the purposes of the Factories and Workshops Act, 1901, so far as it applies to quarries and pitbanks as defined in Part II of the Sixth Schedule to that Act.
