FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1924 (No. 58).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

Contraction of certain Infected Areas.

1. The Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 34) as amended by the Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 51), and the Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 55), shall be read and have effect as if the Areas Nos. 2 and 15 described in the Schedule to this Order were substituted respectively for the Infected Areas Nos. 2 and 15 described in the First Schedule to the last mentioned Order.

Landing of Animals at Glasgow.

2. Article 3 (f) of the Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 34) shall cease to apply to the approved Landing Place at the Port of Glasgow.

Commencement.

3. This Order shall come into operation on the sixteenth day of April, nineteen hundred and twenty-four.

Short Title.

4. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1924 (No. 58), and shall be read with the Orders referred to in Article 1.
