

“ 3. The gratuities payable to ratings who volunteer and are accepted for service in the Coast Watching or the Coast Preventive Force to be subjected to such deduction as may be decided by the Admiralty in conjunction with the Treasury.

“ 4. The grant of compensation on the foregoing terms not to preclude the payment of removal expenses to their future residence or the issue of a plain clothes gratuity under the regulations applicable to Old Force ratings.

“ SCHEDULE B.

“ REDUCTION OF COAST GUARD (NEW FORCE).

“ The following compensation to be paid to officers and ratings discharged from the Coast Guard (N.F.), on reduction of that Force.

“ Officers.

(a) The discharge gratuity for which they are eligible under paragraph XI of Section IX Schedule V of Order in Council of the 22nd January, 1920, for service up to the 31st March, 1923.

(b) An additional gratuity of £3 for Divisional Chief Officers and £2 5s. for Chief Officers for each complete calendar month intervening between the date of discharge and the date on which they would attain the age of 55.

(c) A special gratuity of £37 10s. for each complete period of 3 calendar months by which their services were curtailed through discharge prior to attaining the age of 55, subject to a maximum of £500 per officer.

“ Ratings.

(a) A discharge gratuity for service up to the date of discharge at the rate of 25s. in the case of a Petty Officer, and 20s. in the case of a Coast Guard, for each complete calendar month served as Petty Officer and/or Coast Guard in the New Force.

(b) An additional gratuity of 16s. 8d. for Grade II ratings and 13s. 4d. for Grade III ratings for each complete calendar month intervening between the date of discharge and the date on which they would attain the age of 50.

(c) Ratings whose substantive pay at the date of discharge exceeded the minimum rate of pay of Grade III of the Coast Guard, New Force, to be paid a gratuity calculated at the rates shown below for each complete calendar month by which their services were curtailed through discharge prior to reaching the age of 50.

(d) Ratings actually in receipt of marriage allowance at the date of discharge to be paid additional compensation based on the number and ages of their children then under 14 years of age, and on the period for which they would have been eligible for marriage allowance in respect of each such child, if the men had continued in the Service until the age of 50.

“ The gratuities payable to Officers and Ratings who volunteer and are accepted for service in the Coast Watching or the Coast Preventive Force to be subjected to such deduction as may be decided by the Admiralty in conjunction with the Treasury.

WHEREAS it is among other things provided by the Copyright Act, 1911, that His Majesty may, by Order in Council, extend the said Act to any territories under His protection, and that on the making of any such Order, the said Act shall, subject to the provisions of the Order, have effect as if the territories to which it applies were part of His Majesty's Dominions to which the said Act extends:

And whereas by treaty, capitulation, grant, usage, sufferance and other lawful means His Majesty has power and jurisdiction within the Tanganyika Territory:

Now, therefore, His Majesty, by and with the advice of His Privy Council, and by virtue and in exercise of the powers in this behalf by the Copyright Act, 1911, or otherwise in His Majesty vested, is pleased to order, and it is hereby ordered, as follows:—

1. The Copyright Act, 1911, shall extend to the Tanganyika Territory subject to the following modification:—

In the application to existing works of the provisions of Sections 19 (7), 19 (8) and 24 of the Copyright Act, 1911, the date upon which the said Act shall come into operation
