ORDER OF THE BOARD OF TRADE DATED APRIL 28, 1924, UNDER SECTION 114 OF THE ARMY ACT AS AMENDED BY THE ARMY ANNUAL ACT, 1919 (9 & 10 Geo. 5, c. 11) REQUIRING OWNERS OF Horses, Mules and Asses to fill in the CENSUS FORM.

Order by the Board of Trade as the Authority to whom the Army Council has delegated its powers under Section 114 of the Army Act.

- 1. All owners of horses, mules and asses are required, under the above mentioned Section, to fill up (in duplicate) the form prescribed by the Army Council in their Regulations regarding the Census of Horses, 1924, giving the required particulars in respect of all horses (including foals and yearlings) and of all mules and asses owned by them on the 4th June,
- 2. If the owner is notified that the Return will be called for he must complete the Return and hand it to the constable or other representative of the Chief Officer of Police who calls for it.

If the owner is not so notified he must com-plete the Return and forward it to the Police Station named at the back of the form.

(Forms may be folded and posted without covering envelopes, and postage need not be prepaid.)

CENSUS OF HORSES, 4TH JUNE, 1924 (GREAT BRITAIN).

AUTHORISATION OF CONSTABLES, ETC.

The Army Council having, on 11th March, 1924, delegated to the Board of Trade their powers under Section 114 of the Army Act (except in Ireland) so far as those powers relate to horses and having ordered on the 11th March, 1924, that any constable or any officer of the Remount Department shall be a " proper officer "within the meaning of Section 114 of the Army Act, the Board of Trade, in accord-ance with that Section of the Army Act, hereby authorise any police constable or any Army officer of the Remount Department (except in Ireland) at all reasonable times to enter any premises in which he has reason to believe that any horses are kept and to inspect any horses which may be found therein.
