THE ROADS ACT, 1920.

COUNTY OF SOUTHAMPTON.

Notice is hereby given, that on the sixth day of May, 1924, the Minister of Transport made an Order under Section 7 (4) of the Roads Act, 1920, amending a previous Order made by him under that sub-section on 26th April, 1923, in respect of certain roads in the County of Southampton.

The original Order provided, amongst other things, that for a period of one year from the 21st May, 1923, and subject to certain exceptions, no person should drive or cause to be driven on the road in the Rural District of Ringwood from the District Boundary at Thorney Hill via Burley to the Bournemouth-Lyndhurst road near Vinney Ridge any mechanically-propelled vehicle which had an unladen weight exceeding three tons or which had seats for more than twenty persons exclusive of the driver.

The effect of the amending Order of 6th May, 1924, is to substitute a period of "two years" in respect of the provision cited above for the period of "one year" mentioned in the original Order.

Short Title.

2. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1924 (No. 83) and shall be read with the Orders referred to in Article 1.
