**NATIONAL HEALTH INSURANCE.**

The National Health Insurance Joint Committee and the Minister of Health hereby give notice, pursuant to the provisions of Section 113 of, and the Ninth Schedule to, the National Insurance Act, 1911, that it is proposed to make a Special Order under paragraph (i) of Part II of the First Schedule to the said Act providing that employment in Wales by a local authority or other public authority in the removing of snow in or about any streets or other public places is of such a nature that it is ordinarily adopted as subsidiary employment only and not as the principal means of livelihood:

And the said Joint Committee hereby give further notice that it is proposed, with the approval of the Treasury, to make a Special Order under the proviso to Section 1 (2) of the said Act providing that any person employed in Wales by a local or other public authority in the removing of snow in or about any street or other public place, where the person so employed is otherwise employed by the authority to whom the service is rendered, shall be included amongst the persons employed within the meaning of Part I of the said Act.

A draft of the proposed Order may be obtained free of cost on application to the Solicitor, Ministry of Health, Whitehall, S.W. 1.

Objections to the draft Order by or on behalf of any person affected by the provisions thereof must be sent in writing, within twenty-one days from the date of this Notice, to the Secretary to the said Joint Committee at the above address.
