DANGEROUS DRUGS ACTS, 1920 AND 1923.

WITHDRAWAL OF AUTHORISATION (HAROLD CHARD).

Whereas Harold Chard, of 7, Providence Street, Ipswich, being a person duly registered under the Pharmacy Act, 1868, as amended by the Poisons and Pharmacy Act, 1908, has been convicted of offences against the Dangerous Drugs Acts, 1920 and 1923:

And whereas the said Harold Chard cannot, in my opinion, properly be allowed to be in possession of or supply raw opium, nor to carry on the business of manufacturing or selling or distributing any of the drugs to which Part III of the Dangerous Drugs Act, 1920 applies.

Now, therefore, after consultation with the Council of the Pharmaceutical Society of Great Britain, and in pursuance of the powers conferred upon me by No. 6 of the Raw Opium Regulations, 1921, and by No. 10 of the Dangerous Drugs Regulations, 1921, I hereby give notice that I withdraw, as from to-day's date, from the said Harold Chard the authorisations granted by the said Regulations to persons who lawfully keep open shop for the retailing of poisons in accordance with the provisions of the Pharmacy Act, 1868, as amended by the Poisons and Pharmacy Act, 1908, to be in possession of and supply raw opium and to carry on the business of manufacturing, selling or distributing the drugs to which Part III of the Dangerous Drugs Act, 1920, applies.
