

in Council, 1904 (S.R. & O., 1904, No. 1784), as amended by the County Courts Extended Jurisdiction (Amendment) Orders, 1919 to 1923 (S.R. & O., 1923, No. 1512), shall be further amended as follows:—

(i) In Circuit 17, (a) Gainsborough is removed from the second column of the said Schedule, and (b) Brigg and Scunthorpe are removed from the third column thereof.

(ii) In Circuit 59, (a) Bodmin is removed from the second column of the said Schedule, and (b) Liskeard is removed from the third column thereof.

2. This Order may be cited as the County Courts (Extended Jurisdiction) Order in Council, 1924, and the County Court Extended Jurisdiction (Amendment) Orders, 1919 to 1923, and this Order may be cited together as the County Courts Extended Jurisdiction (Amendment) Orders, 1919 to 1924.

3. This Order shall come into operation on the 1st day of July, 1924, and the County Courts Order in Council, 1904, as amended, shall have effect as further amended by this Order

**WHEREAS** the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 15th day of May, 1924, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken out of the New Parish (sometime District Chapelry) of Little Marsden, in the County of Lancaster and in the Diocese of Manchester:

"Whereas we are satisfied that the said New Parish of Little Marsden is a Cure wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the particular part of the said New Parish of Little Marsden which is hereinafter mentioned and described should be constituted a separate District in the manner which is hereinafter set forth:

"And whereas there is not at present within the limits of the said proposed separate District any consecrated Church or Chapel in use for the purposes of Divine Worship:

"And whereas we have agreed to make and pay out of the Common Fund created by the firstly herein mentioned Act a grant of £200 per annum to the Minister of the said proposed separate District so soon as a Minister shall have been duly licensed in accordance with the provisions of the secondly herein mentioned Act and to his successors:

"And whereas the said grant of the said yearly sum of £200 will, after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme, be made and secured by an Instrument to be executed by us, the said Ecclesiastical Commissioners, under our Common Seal in accordance with the provisions of the Act of the 29th and 30th years of Her said late Majesty, Chapter 111:

"And whereas Eliza Jane Dixon, late of Number 121, Ormerod Road, Burnley, in the said County of Lancaster, Spinster, who died on the 19th day of May, 1915, by her will dated the 7th day of January, 1915, directed that if within a period of twenty-one years after her decease and under or in pursuance of The New Parishes Acts, 1843, 1844, and 1856, or any of them or any Act or Acts consolidating or amending the same respectively or other legal authority any part or parts of the following existing Ecclesiastical Parishes, namely, Great Marsden; Little Marsden; Saint Mary, Nelson; Saint Philip, Nelson; and Brierfield, all in the said County of Lancaster, or of any one or more of them should be duly constituted a separate District or separate Districts for spiritual purposes the Trustees or Trustee for the time being of her Will should transfer to or vest in the Ecclesiastical Commissioners for England or any other Commissioners, Corporation, or public body, who may be legally authorized in that behalf, out of her residuary estate the sum of Three thousand pounds free of duty for or towards the provision of a Church or Chapel, Churches or Chapels, for such District or respective Districts or for such one or more of them as the said Commissioners, Corporation or other public body should in their discretion think fit and for or towards the endowment or augmentation of the income of the Minister or perpetual Curate, Ministers or perpetual Curates, thereof or for either of such purposes respectively and if for both such purposes or for more than one such District then in such proportions as such Commissioners, Corporation or other public body as aforesaid should in their discretion think most beneficial:

"And whereas Walter Southern, of The Craven Bank Chambers, Burnley, in the said County of Lancaster, Solicitor, being the surviving Trustee of the said Will, has agreed, with the approval of us, the said Ecclesiastical Commissioners, to the appropriation of the whole of the said sum of Three thousand pounds towards the provision of a permanent Church for the proposed District of Saint Bede, Nelson, which is to be taken out of the said New Parish of Little Marsden, such appropriation to be made when and so soon as the said District shall have been duly formed and constituted as a Peel District within 21 years after the death of the Testatrix:

"And whereas the said Walter Southern as the contributor of the said capital sum of £3,000 towards the cost of providing such permanent Church has nominated the Bishop
